

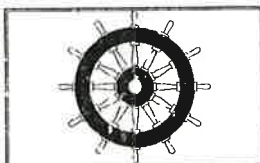

2.) Marking :

The manual has to be according to the muster approved by the BG Verkehr and BAM. Date of manufacture (month/year) and date of expiry (**max. 36 months**) is to be marked delivery of the production place.

A permanent and seawater proof marking with name of manufacturer, type, approval-number and the mark of conformity and the manual is required.

3.) Quality insurance and production control :

This type approval will be only valid in connection with a certified quality system according to module D of the directive 96/98/EC as amended.

4.) Description: One line-throwing appliance consists of a launching device with projectile and a container with a square synthetic ropes, length 260 m, diameter 4 mm. The rope breaking strength is 4 kN, with knots at least 2 kN.

5.) Requirement: For compliance with SOLAS 74 as amended Chapter III /18 and LSA Code Chapter VII / 7.1.1 - four (4) line-throwing appliances as above mentioned must be stored on board.
